3. The vehicles may be inspected on any working day between 0930 and 1530 hours, excluding Saturdays, Sundays, and public holidays.
4. Prospective bidders must submit a refundable bid security equal to Rs 50,000 per Vehicle and Rs 5,000 per motorcycle. The security shall be in the form of a Pay Order issued by a scheduled bank with a minimum AAA-rating located in Karachi, in favour of Korangi Fisheries Harbour Authority.
5. Sealed bids/quotations shall be submitted on 24-7-2026 at 1100 hours in the office of Manager (Admin) KoFHA, Karachi.
6. Bids will be opened on the same day at 1130 hours in the Committee Room of the Administration Building, KoFHA, Karachi, in the presence of bidders or their authorized representatives who wish to attend.
7. Late submissions will not be entertained. Bids submitted without the required bid security shall be rejected.
8. KoFHA reserves the right to accept or reject any or all offers in accordance with PPRA Rules 2004. The Authority's decision shall be final and binding on all parties.

### 1. INTRODUCTION

Korangi Fisheries Harbour Authority, Government of Pakistan invites sealed bids from eligible bidders for the auction of condemned/unserviceable vehicles in accordance with rule 36 (a) of PPRA 2004.

### 2. SCOPE OF AUCTION

The department intends to dispose of the following vehicles on “**As-Is, Where-Is**” basis:

### 3. INSTRUCTIONS TO BIDDERS

#### 3.1 Eligible Bidders

- a- Individual Pakistani / firm / company
- b- Must provide:
  - i. CNIC / NTN / Registration Certificate
  - ii. Active Taxpayer status (ATL)
- c- Must not be blacklisted by any Government organization

#### 3.2 Cost of Bidding

The bidder shall bear all costs associated with preparation and submission of bid. The KOFHA shall not be responsible for such costs.

#### 3.3 Clarification of Bidding Document

Bidders may request clarification in writing up to 03 days before submission deadline.

#### 3.4 Inspection of Vehicles

Bidders are strongly advised to inspect the vehicles on As is Where is basis. No claim whatsoever shall be entertained after bidding.

#### 4. BID SECURITY (Earnest Money) (Refundable)

- a- Amount: Rs. 50,000/- per vehicle and Rs.5,000/- per motorcycle.
- b- Form: Call Deposit Receipt (CDR) / Pay Order in favor of **“Korangi Fisheries Harbour Authority”** issued by a scheduled bank with a minimum AAA-rating located in Karachi.
- c- Non-compliant bids shall be rejected.
- d- Bids Without bid security shall not be considered.
- e- Bid Validity is 60 days

#### 5. PREPARATION OF BIDS

##### 5.1 Language

Bid shall be prepared in English/Urdu.

##### 5.2 Bid Price

- a- Price must be quoted:
  - i. In Pak Rupees (PKR)
  - ii. Both in figures and words
- b- Price shall be **exclusive of applicable taxes**

##### 5.3 Documents to be submitted

- a- Bid Form (Annex-I)
- b- Copy of CNIC / Registration documents
- c- Bid Security
- d- Affidavit of non-blacklisting

#### 6. SUBMISSION OF BIDS

##### 6.1 Method

Single Stage – One Envelope Procedure under PPRA Rule 36(a)

##### 6.2 Sealing & Marking

Envelope must be clearly marked:

**“BID FOR AUCTION OF CONDEMNED VEHICLES & MOTORCYCLE AT KOFHA – DO NOT OPEN BEFORE 24-7-2026 by 11:30 AM**

##### 6.3 Deadline

Late bids shall be rejected as per PPRA Rule.

## **7. BID OPENING**

- a- Date: As per NIT
- b- Time: As PER NIT
- c- Venue: AS PER NIT

Bids shall be opened publicly in presence of bidders'/ representatives as per PPRA Rules 28(2).

## **8. EVALUATION OF BIDS**

- a- Evaluation shall be conducted on **lot-wise highest bid basis**
- b- Bids shall be checked for:
  - i. Responsiveness
  - ii. Valid bid security
  - iii. Completeness

Non-responsive bids shall be rejected.

## **9. AWARD OF CONTRACT**

### **9.1 Criteria**

- Highest evaluated responsive bid above reserved price shall be accepted.

### **9.2 Right to Accept or Reject**

The Procuring Agency reserves the right to accept or reject any or all bids in accordance with PPRA Rule 33.

## **10. PERFORMANCE / PAYMENT TERMS**

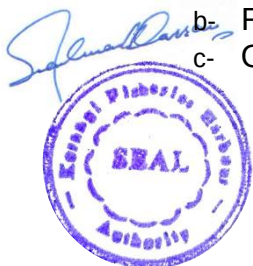
- a- Successful bidder shall deposit remaining amount within 03 days of issuance of Acceptance Letter
- b- Failure shall result in:
  - i. Forfeiture of Bid Security
  - ii. Cancellation of award

## **11. TAXES & DUTIES**

- All applicable taxes (Income Tax, GST, etc.) shall be borne by the successful bidder as per Government rules and FBR regulations.

## **12. DELIVERY & REMOVAL**

- a- Vehicles shall be handed over after full payment.
- b- Removal must be completed within 03 days.
- c- Ground rent Rs.1000 per vehicle/ per day shall be charged after deadline.



### **13. TRANSFER OF OWNERSHIP**

- a- Transfer shall be carried out by the successful bidder at his own cost from relevant Excise & Taxation Authority.
- b- Any pending token taxes shall be paid by bidder.

### **14. FRAUD & CORRUPTION**

Bidders shall comply with Government of Pakistan's policy on fraud and corruption. Any attempt to influence the process shall result in disqualification.

### **15. BLACKLISTING**

The Auction Committee may blacklist a bidder in accordance with PPRA Rules

- a- Misrepresentation
- b- Failure to perform obligations

### **16. DISPUTE RESOLUTION**

Any dispute shall be resolved as per arbitration act 1940, place of arbitration will be Karachi.

### **17. SPECIAL CONDITIONS OF CONTRACT (SCC)**

- a- Vehicles are sold strictly on "As-Is, Where-Is" basis
- b- No warranty or guarantee
- c- Department shall not entertain complaints post-award
- d- Vehicles cannot be cannibalized/dismantled at site
