HIRING OF SECURITY SERVICES FOR KORANGI FISHERIES HARBOUR AUTHORITY

INVITATION TO E-BID

Korangi Fisheries Harbour Authority (KoFHA) invites e-bids for “Hiring of Security Services at KoFHA” from reputed registered Security Companies which are holding valid license from Ministry of Interior, Islamabad and Home Office, Govt. of Sindh for providing security guards services for key points & KoFHA Land. The company should provide security guards retired from Pak. Army, Rangers, Mujahid Force, FC, Coastal Guards for a period of one year (extendable for 1 year on satisfactory performance), subject to terms and conditions specified in the tender documents “on Single Stage - Two Envelope bidding procedure, as stated in Pakistan Public Procurement Rules-36(b).

Single Stage-Two Envelope Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).

E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://epads.gov.pk/opportunities/federal/procurements/55949>.

Bid Security not less than PKR 500,000 (Pak. Rupees Five Hundred Thousand) shall be in the form of a Pay Order or a Bank Guarantee from any Scheduled Bank of Pakistan having minimum AAA is to be submitted in the office of Manager (Admin), Korangi Fisheries Harbour Authority (KoFHA), Chashma Goth, Rehri District Malir Karachi on or before closing time of bid submission. The Bid Security shall be in favor of Korangi Fisheries Harbour Authority valid for a period of one hundred forty-eight (148) days. The Bid Security from an insurance company shall not be accepted.

The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before Monday, July 27, 2026 02:00 PM. E-bids will be opened on the same day at Monday, July 27, 2026 02:30 PM. Manual submission of Bids shall not be entertained. Those vendors who have not yet registered on the new version of EPADS v2.0, may register themselves on <https://vendors.epads.gov.pk/>.
